e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 = fell because of excessive shading to front elevation, overhanging the main house causing regular blocking of gutters, tree root damage to property (ground floor), historic foundation rotation, ground displacement (private drive and public pavement) and damage to the existing drainage provisions.

Proposal to fell and replace with 1nr flowering Chinese dogwood to provide high amenity value to the rear garden.

IF, the LPA do not consider the tree should be removed then we request consent for immediate pruning and cutting back. (damage is ongoing) whilst we prepare a robust case and specialist report in support of its removal.

All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)
