T2. Sycamore (Acer psuedoplatanus)

Rear garden. Behind garage.

Large mature specimen tree not maintained for some time now encroaching on no.55 and neighbouring property. To improve light and clearance and reduce transpiration rates, suggest:

Reduce canopy all round by approximately 25% balance and shape (reduce canopy height by 3m and lateral spread by 3m to growth points)

Prune away from properties to give a minimum of 3m clearance. Remove deadwood and crossing branches. Crown lift by 3m all round.
