- Pollard to remove all sprouts from cut ends of branches to maintain size and appearance.
- Dismantle with rigging techniques the leaning T1 Corkscrew Willow located at the front of house left side.

We will install the following plant at the right front of property:

- (1) 6-8 cm Snake bark maple.

Prune T2 Bay located at the left side rear corner of garden according to the following specifications:

- Reduce crown height by approximately 2-3 metres to renovate overgrown tree.
