OakT10 (10M high, 200mm dia.) - Remove 2 low lateral branches back to stem.

Pear T11(12m high, 500mm dia.) - Dead - Fell

3 x Holly & 1 x Box Elder G12 (8M high, average 100mm dia.) - Fell
