T1London Plane, Large end specimen part of linear group specimen, starting to encroach on the adjacent buildingGeneral maintenance, to include Climbing Inspection for Massaria, to include Massaria Report

T2Maple, Part of linear group behind retaining wall on Pond Street, adjacent to Royal Free Hospital. Poor pruning stub's at 2 mtr's General maintenance, to include correct pruning of stub cuts

T3LimePart of linear group behind retaining wall on Pond Street adjacent to Royal Free Hospital. X 3-5 sections of deadwood above 30mm in diameter within the canopyGeneral maintenance, to include lifting lower epicormic growth and branches' to the main crown break at approximately 4mtr's

T4Lime, Part of linear group, behind retaining wall on Pond Street, adjacent to pedestrian entrance into hospital. X 3-5 sections of deadwood above 30mm in diameter within the canopyGeneral maintenance, to include lifting lower epicormic growth and branches' to the main crown break at approximately 4mtr's

T5London Plane, Part of linear group, behind retaining wall on Pond Street, adjacent to pedestrian entrance into hospital. X 3-5 sections of deadwood above 30mm in diameter within the canopyGeneral maintenance, to include Climbing Inspection for Massaria, to include Massaria Report
