T1Sycamore x 1 (Acer pseudoplatanus) This previously reduced tree has out-grown its location to improve light and slow root expansion.

Suggested works:

- Reduce all round to previous reduction points approx. 6m

Front garden

T2Cypress x 1Suggested works:

- Trim to shape and contain

Rear garden

T3Pear x 1(Pyrus communis) To slow root expansion and improve light.

Suggested works:

- Reduce all round by approx. 2m to suitable growth points.

Rear garden of no3

T4Fig x 1(Ficus carica)This tree is encroaching on property to slow root expansion and clear property and improve light.

Suggested works:

- Reduce all round by approx. 4m to suitable new growth points

Rear garden of no5

T5Cherry x 1(Prunus spp)To improve light.

Suggested works:

- Reduce all round by 2m to suitable growth points and clean out crown.
