IN ESTATE GROUNDS: 1 x Sycamore Maple (*Acer pseudoplatanus*) (T952) - Fell to ground level.

1 x Lawson Cypress (*Chamaecyparis lawsoniana*) (T953) - Crown lift to a height of 4m over access road.

1 x Crabapple (*Malus ssp*) (T963) - Crown lift to a height of 4m.

1 x Cotoneaster (T971) - Crown lift to a height of 4m.

1 x Cotoneaster (T972) - Crown lift to a height of 4m.

1 x Crabapple (*Malus ssp*) (T1609) - Crown lift to a height of 4m over path.

The Council has considered your notification of intended works to trees dated 06 January 2021 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
