Proposal:

WOODLAND AREA opp. 111 FROGNAL: 1 x Lime (Tilia) (T4) - Reduce by 30% foliage, approximately 2 - 3m from branch ends, not beyond most recent reduction points
1 x Sycamore Maple (Acer Pseudoplatanus) (T7) - Crown clean by reduction of over extended limbs over road (2m from branch ends).

The Council has considered your application dated 16 February 2021 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
