### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Bay (T1) - Reduce crown height by approx. 3m - 4m to enhance natural form. Trim sides all round to make a more compact rounded shape.

1 x Elderberry (T2) - Pollard to remove all sprouts from cut ends of branches to maintain size and appearance.

1 x Elderberry (T4) - Clean to remove all diseased and broken branches 2cm in diameter and larger throughout crown.

1 x Elderberry (T5) - Reduce back to a 2m tall stem to provide clearance to tree at rear of garden.

The Council has considered your notification of intended works to trees dated 23 February 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
