### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Beech (T2) - Thin crown density by approx. 20 - 25%.

1 x Holly (T3) - Reduce overlong branches by approx. 1m - 1.5m back into main crown structure in order to shape and balance the crown.

1 x Sycamore (T4) - Thin crown density by 20 - 25 %, selecting strongest branches for retention. Reduce back to previous, most recent reduction points whilst retaining a suitable amount of furnishing growth. Remove decaying sub ended branches.

Row of Leyland Cypress (G1) - Reduce lateral and sub-lateral overhang (tip prune) as is practicable whilst preserving screen and healthy crown structure.

The Council has considered your notification of intended works to trees dated 25 February 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, which ever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
