2 x Mature Lime trees on garden border with The Grove: Reduce overall crown by up to 2.5 metres whilst retaining natural flowing canopy; remove epicormic growth; remove dead and dangerous branchwood; crown lift to 5 metres to provide clearance over the road and pavement. All cuts will be made to suitable growth points in line with BS3998.

Laurel Hedge along border with 7 Hampstead Lane: Reduce height by 1.5 metres and trim sides into tidy and uniform shape.

Mimosa tree at rear of garden: reduce overall crown by 2.5 metres

Holm Oak in 7 Hampstead Lane: Reduce height and sides on East side by up to 1 metre to provide more light into garden.
