
As owner and resident of 33 Heath Drive, London NW3 7SB since 1989, please accept this correspondence as a formal objection to the application, stated above. I would restate that I have neither granted any permission for the applicant or any representative of the applicant access to the property for a site review of the trees nor to submit said application.

Further to the above referenced application, please be advised that as owner of 33 Heath Drive, the property in question, please accept this email as formal notification of objection to this application. I have not provided permission to anyone to apply to carry out works on any trees located on my property. I allowed the tree in question to be pruned last year but only as to remove any infringement on the property next to ours, and have been independently advised by our gardeners that there is no impingement on said property.

I have engaged a tree surgeon to conduct a thorough review of all trees on our property and in accordance with his proposal that is forthcoming, we will be submitting an application to conduct any augmentation to the trees that he deems necessary.

I am happy to discuss this matter and have formally logged a call into the tree division to state my position and am awaiting a call back today.
