e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Indian Bean Tree T1 (15M long, 800mm dia.) - severe lean over neighbours garden and almost prone. Fell

Ginkgo T2 (16M high, 500mm dia.) - reduce crown of the tree by up to 4 metres back to the most recent points of reduction. Remove 150mm diameter very low lateral branch on south side.

Ginkgo T3 (16M high, 500mm dia.) - reduce crown of the tree by up to 4 metres back to the most recent points of reduction.

Ash T4 (18M high, 700mm dia.) - Raise canopy of tree crown by removal of low epicormic growth and thin crown by 30% throughout by removal of epicormic growth and minor branches. Remove very low 120mm diameter branch on north side of tree over neighbours property roof.
