e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden with Side access Trees numbered as per enclosed plan:

T1 – Lime tree close to adjacent property – -Cut back crown to points of previous reduction.

T2 – Large Ash -

Decay evident in several parts of lower crown. We advise: -Reduce regrowth from previous reduction points by 2-3meters.

T3 – Pear. With signs of die-back in crown. We advise:

-Remove dead-dying branches, reshape as necessary.

T4 – Extra-large Sycamore –

-Remove deadwood and branches only. G5 – Group of Portuguese Laurels –

-Cut back to leave at half a meter in height to allow more light into young Beech.
