e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1- 1x Bay(Laurus nobilis)-nearest boundary wall
-reduce height of both trees by 30%(2m) to suitable growth points
-cut back front face and sides of both trees by 1m to shape and tidy

T2-Bay(Laurus nobilis)
-trim back inbound branches to clients' property ups to 4m above ground level

T3-Lilac(Syringa sap)
-remove long tall stem to low union
-install wooden ro metal support to lift low hanging inbound limb to more upright position using soft rubber ties to avoid bark rubbing/damage

T4-Fig(Ficus carica)
-prune any branch growth overhanging pavement to suitable growth points
