Prune T1 Turkey Oak located at the left front of house according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown.

Most thinning cuts will be between 1 and 2 centimetres in diameter.

- Reduce crown height and spread by approximately 1-2 metres to enhance natural form.
- Reduce back to previous prune points to maintain a more compact shape and keep within the insurance specification requirements

Prune T2 Hawthorn located at the left front of house according to the following specifications:

- Reduce crown height by approximately 2-3 metres to enhance natural form.
