- -Remove all regrowth formed since last works (approximately 4meters) back to original growth points.
- Sever Ivy on T2.
- T3 Large Acacia
- -Reduce crown height by approximately 3-4meters (regrowth) pruning back to second timber.
- -Reduce laterals by 2meters.
- Remove major deadwood.
- NB: This tree has a compression fork at 2.5meters & should be monitored at regular intervals.
