-Remove all regrowth formed since last works (approximately 4meters) back to original growth points.

-Sever Ivy on T2.

T3 - Large Acacia –

-Reduce crown height by approximately 3-4meters (regrowth) pruning back to second timber.

-Reduce laterals by 2meters.

-Remove major deadwood.

NB: This tree has a compression fork at 2.5meters & should be monitored at regular intervals.
