e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Pear: Approximately 9.00m. Section fell to as near to ground level as is practicable and treat stump with systemic herbicide.
Reason: The tree is in poor condition and has little aesthetic value.

T2: Large Oak:

Approximately 15.00m. Remove epicormic growth from the main stem. Reduce back to previous, most recent reduction points (approximately 1.00-1.50m), retaining a suitable amount of furnishing growth to ensure crown continuity. Thin crown density throughout by approximately 20%. Remove dead wood.

Reason: General maintenance to manage the tree at reasonable dimensions for its location and increase light levels.

T3: Mature Lime:

Approximately 13.00m. Overhanging from a neighbouring property. Remove dead wood. Reduce overhanging branches by approximately 30% (2.00m).
Reason: General maintenance to control encroachment.
