REAR GARDEN: 1 x Mimosa tree (T1) - Fell and poison stump.  
1 x Mimosa tree (T2) - Overall crown reduction by approx. 1.5m.  
1 x Eucalyptus (T3) - Fell and poison stump.  
2 x Eucalyptus (T4 & T5) - Overall crown reduction by approx. 1.5m.
