**GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER**

Proposal:  
FRONT GARDEN: 1 x Lime - Reduce height and spread to 0.6m - 1m above previous reduction points to leave as much furnishing growth as possible. Thin crown throughout by 10%. Remove all trunk growth to a height of 0.6m.  
REAR GARDEN: 1 x London Plane - Reduce height and spread by 3m - 4m. Thin crown throughout by 15%

The Council has considered your application dated 05 March 2021 and decided to grant consent subject to the following condition(s):

#### Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
