e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Boundary:

T1: Red Horse Chestnut: Approximately 14.00m. Located in the righthand corner. Remove Ivy. Thin crown density throughout. Remove dead wood and broken branches. Reduce lateral and sub-lateral branches growing towards properties on Fellows Road by 20%. Reduce extraneous branches back into main crown structure (not more than 20%).

T2: Lime: Approximately 21.00m. Thin crown density throughout by 20%. Reduce lateral and sub-lateral branches growing towards Fellows Road by 20-25%. Remove dead wood.

T3: Red Horse Chestnut: Approximately 14.00m. We recommend to treat as T1.

Reasons: - To help increase light levels and control encroachment of overhanging branches.

- Reduce hazard potential and wind resistance.
- Manage the trees at reasonable dimensions for their locations.
- Remove/control climbing plants.
