Mr and Mrs Chandler	06/04/2021 00:14:04	OBJ	This is a quiet residential area and the pub has not been allowed to have tables and chairs out after 9pm because of this, as it would cause high levels of disturbance to residents living close by (who are already kept awake by the noise in the beer garden at the rear). Adding more tables and chairs outside the front will increase noise levels and attract further people to hang around outside. This is not an appropriate location for an increased presence on the street of loud and drunk people adjacent to a council estate where related the large blue table and four chairs drawn on the plan (which has never previously been located there) is literally adjacent to the entry gate to the block. So the current plan is not accurate in this regard.
				I note also that the pavement is not wide enough to allow for two layers of tables and chairs. What has been drawn is not physically possible as it means that people in the two lines of tables will be literally sitting 10cm away from each other, shoulder to shoulder, and not socially distanced. The plan as drawn is therefore not accurate and gives a talse impression that there is sufficient space for the arrangement as proposed, which there is not. There is also no way to keep people from moving the tables further away so that they have an adequate amount of space to sit in, which will mean the remaining free pavement will be too narrow for people to pass by easily.
				We have suffered with people standing outside after leaving the pub shouting at each other, urinating and vomiting into my basement lightwell and adainst my garden wall and door for a number of years now. No control is exercised over people in terms of dispersal as there are very few staff on hand and no-one is on door duty (unlike pubs on the I-tigh Street). We therefore have absolutely no confidence that the additional tables and chairs will be adequately policed by the staff, nor that noise volumes will be kept low. Unfortunately some of the people who use this pub are quite intimidating and make it unpleasant to pass by - especially during some match days.
