We enjoy its appearance and the wide variety of fauna, including owls, for which it provides a habitat.</p> <p>I strongly object to the application to fell the tree on the basis that:</p> <p>(a) The character of this conservation area is enhanced by the large plane tree; its removal would detract from neighbours' views and detract from the local environment.</p> <p>(b) Removing this tree would prejudice the habitats of bird life, including, we understand, great spotted woodpeckers, tawny owls and jays. These are now quite unusual in urban areas such as this and deserve to be preserved.</p> <p>(c) The proposed felling seems to be part of a continuing trend to remove significant mature trees in this road. Each removal detracts from the character of the area and from natural habitats.</p> <p>(d) We echo the arguments of Adshead and Wade that the case for this tree's removal appears weak.</p>

These are old buildings that do shift around and so unless there is an immediate risk of collapse or need for costly support or underpinning works the tree should be preserved.</p>
2021/1435/T	Dmitri Alibegov	09/04/2021 13:10:55	OBJ	<p>Whilst I have a certain amount of sympathy to subsidence claims where damage is caused by tree root systems, it seems to me that in this case the causality and the link to this particular tree, which is located a good distance away from 16 Belsize Park Gardens, is not sufficiently established. There is a mature plane tree located in front of number 16 and much closer to the property, and nobody even considered which tree is causing the damage. Given the significance of the tree at 28A Glenilla Road to the area, and the fact that this area just lost 3 (some reports mention 2 but this is incorrect) mature sycamore trees fell at 30 Glenilla Road, there should be a very strong case presented for the council to grant this application. I would recommend close consultations with all residents at 16 Belsize Park Gardens, and at other properties that can be affected by the tree. If there is no support from these residents, the application should be denied.</p>
