Rear Garden

G1 - Group of 5 Birch trees - Remove 3 trees due to excessive shade and outgrowing their location in the small garden . The trees are starting to over take the garden and taking out 3 specimens should assist the remaining trees and help the garden with both light and less root damage to Lawn. Crown reduce the remaining trees to previous reduction points by approx 0.5m.

Front Garden -

T1 - Magnolia - Crown reduce by approx 1m to form a formal shape
