Please find attached a tree survey prepared by Crown consultants. This application for consent concerns 5 large shrubs some of which are classified as retention category C and the remainder were unclassified in the tree survey. They are mature specimens which have stems thick enough to fall within the definition of trees which require permission for pruning/reshaping. This application seeks to prune back to the sizes and shapes they were at the time of the tree survey 3 years ago. The trees and the intended works are identified as follows with numbers referring to the tree survey:					
T2 - Ilex in front garden. Standard shape with single stem and round canopy. Reduce canopy by 25% to retain standard form. T11 - pittosporum in rear garden. Reduce canopy by 25% and reshape to previous size as specimen shrub. T 13 Holm oak. Reduce canopy by 30% to reshape to previous size as specimen shrub. Two un-named pittosporum. Their location is shown on the tree survey at the top of the steps and sitting along a line drawn between T15 and T4. Reduce canopy by 25% and reshape to previous size as specimen shrub.
