Front Garden:

T1: Sycamore: Reduce crown height where practicable by approximately 20% (0.50-1.00m). Reduce lateral and sub-lateral branches by 1.00m. Thin crown density by 25%. Remove Ivy by cutting a 300mm swathe at ground level and removing Ivy stems where practicable without causing bark damage.

T2: Olive: Fell to ground level and treat with systemic herbicide.

Reasons: These trees are causing subsidence of the subsoil and shrinkage of the clay component in that soil due to their moisture demands.

Rear Garden:

T3: Plum: Reduce back to previous, most recent reduction points whilst preserving furnishing growth to help ensure crown continuity.

Reason: General maintenance.
