## 5. Identification of Tree(s) and Description of Works

- e.g. Oak (T3) fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden - (righthand borders):

T2: Dead Juniper: Approximately 5.00m. Fell to ground level and grind stumps to approximately 300mm below current ground level.

T3: Yew: Approximately 4.00-5.00m. Growing adjacent to the dead Juniper. Reduce crown height and spread by approximately 50% and allow to regenerate.

T4. Seguoia: Approximately 12.00m. Fell to ground level and grind stump to approximately 300mm below current ground level.

Reason: The tree is growing in an overcrowded area, fast growing and does not add much to the garden.

T5: Juniper: Approximately 4.00-5.00m. Fell to ground level and grind stump to approximately 300mm below current ground level.

Reason: The tree has extensive lateral growth and is growing within close proximity to an outstanding Magnolia.

T6: Yew: Approximately 5.00-6.00m. Reduce crown by approximately 50% and allow to regenerate.

T7: Macrocarpa: Approximately 13.00m. Remove broken, damaged and hung branches throughout crown.

T9 & T10: 2 x Yew: Approximately 5.00m. Reduce height by approximately 1.50m as is practicable. remove one stem restricting pathway between the trees.

Rear Garden - (lefthand side of the lawn): T11: Purple Plum: Approximately 9.00m. Reduce crown by approximately 20% back to previous, most recent reduction points. Tin crown density by 20%.

Raise crown by 1.00m.
T12, T13 & T14: Willow Pollards: Approximately 7.00m Reduce back to previous pollard points.
T15, T16 & T17: 3 X Irish Yews: Approximately 3.00-4.00m. Reduce crown height and spread by approximately 50% and allow to regenerate.

Front Garden:

Hornbeam Hedge: Reduce height to approximately 2.50m.

Reasons: General maintenance unless otherwise specified and to increase light levels for the development of new landscape design.
