rear
t3Lime (Tilia spp)remove ivy down to base-crown lift to 4m
rear
t4Cherry (Prunus spp)forced cherry that is growing up through the adjacent leylandii, fell to ground level and treat stump to prevent any further
rear
t5Cypress reduce height by 2.5m-reduce lateral growth by 1-1.5m growing into the garden
Rear (LHS)
T6Willow (Salix spp)Remove limb growing over neighbouring garden and retain remainder.
Rear(RHS)
T7Forsythia
Fell to ground level as almost dead
