Ash T1 (18M high, 1000mm dia.) - Large over mature tree showing some signs of decline. Very large basal cavity on NE side of the trunk extending up to 3 metres. Large cavities within the crown from previous limb removal. Centre of the crown is missing due to large previous breakout.

- Create scaffold pollard by reducing top down by up to 6 metres. Draw in sides of crown by up to 3 metres. Aerial inspection of cavities.
