The replacement of a dormer window to the front roof pitch with a single glazed vertically sliding sash window to match adjacent historic examples.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 [and D2 if in CA] of the London Borough of Camden Local Plan 2017.

- 3 Reasons for granting permission. [Delegated]

No. 24 Perrins Lane is part of a terrace of listed Grade II cottages which date from the early 19th century. The building is within the Hampstead Conservation Area.

The delapidated and inappropriately designed dormer window on the front roofscape, probably dating from the later 20th century, is to be replaced with a single glazed vertically sliding timber sash window to match the historic examples found in Perrins Lane.

The scheme has been revised in line with discussions with the planning authority to ensure the works are appropriate to this historic listed grade II building. The installation of a skylight which was considered to be harmful, has been removed from the proposals

No responses were received as a result of the public consultation through a

press notice and a site notice.

The site's planning history has been taken into account when making this decision

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.
