T1&2 London plane 2 planes to be Re-Pollarded back to previous pollard points. Removing up to 2m of growth as part of ongoing maintenance.
T3 Sycamore Crown Reduction - Reducing the height and crown spread of the 15m tall tree by up to 2 metres to keep tree in good proportions and as part of ongoing maintenance.
T4 Silver birch Crown lift to 3 m over footway and 5 m of road. Lateral crown reduction of up to 1.5 m over the road and a reduction of up to 1 m on the property side to retain a two meter clearance from buildings. Carried out to follow statutory clearances over highways and to reduce nuisance of trees touching property
