## Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

3 Prior to the end of the next planting season (December 2021 - March 2022), a

single-stemmed Amelanchier arborea "Robin Hill" (Juneberry treee) measuring 14-16cm in circumference at 1m above the root ball shall be planted no less than 5 metres from the site of the application tree and no less that 750mm from any structure unless otherwise agreed with the Council in writing. The tree shall be planted and maintained in accordance with the standards set out in BS8545:2014.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).
