e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore on border with Merton Lane: this tree has signs of decay in the stem and has had bad reduction work done in the past. There are trees on either side so removing it will not affect the foliage cover in this garden. Proposed work: remove tree to ground level. Neighbouring Sycamore tree: reduce longest lateral branches by up to 2 metres to provide a more balanced crown.
