T1: American Horse Chestnut: Approximately 14.00m. Thin crown density by 15-20%. Reduce lateral and sub-lateral branches growing towards and over garden by approximately 1.00m. Remove dead wood. Reduce remaining extraneous branches back into main crown structure (not more than 20% crown reduction). Raise crown by 1.50-2.00m.

T2: Lime: Approximately 21.00m. Thin crown density throughout by 20-25%. Remove dead wood throughout crown. Reduce crown height by up to 2.00m. Reduce lateral and sub-lateral branches by approximately 2.50m. Remove lowest branch overhanging No.146.

T3: American Horse Chestnut: Approximately 14.00m. Thin crown density by 15-20%. Reduce lateral and sub-lateral branches growing towards and over garden by approximately 1.00m. Remove dead wood. Reduce remaining extraneous branches back into main crown structure (not more than 20% crown reduction). Raise crown by 1.50-2.00m.

Reasons: To help increase light levels and control encroachment of overhanging branches. Reduce hazard potential and wind resistance. Manage the trees a reasonable dimensions for their locations. Remove/control climbing plants.
