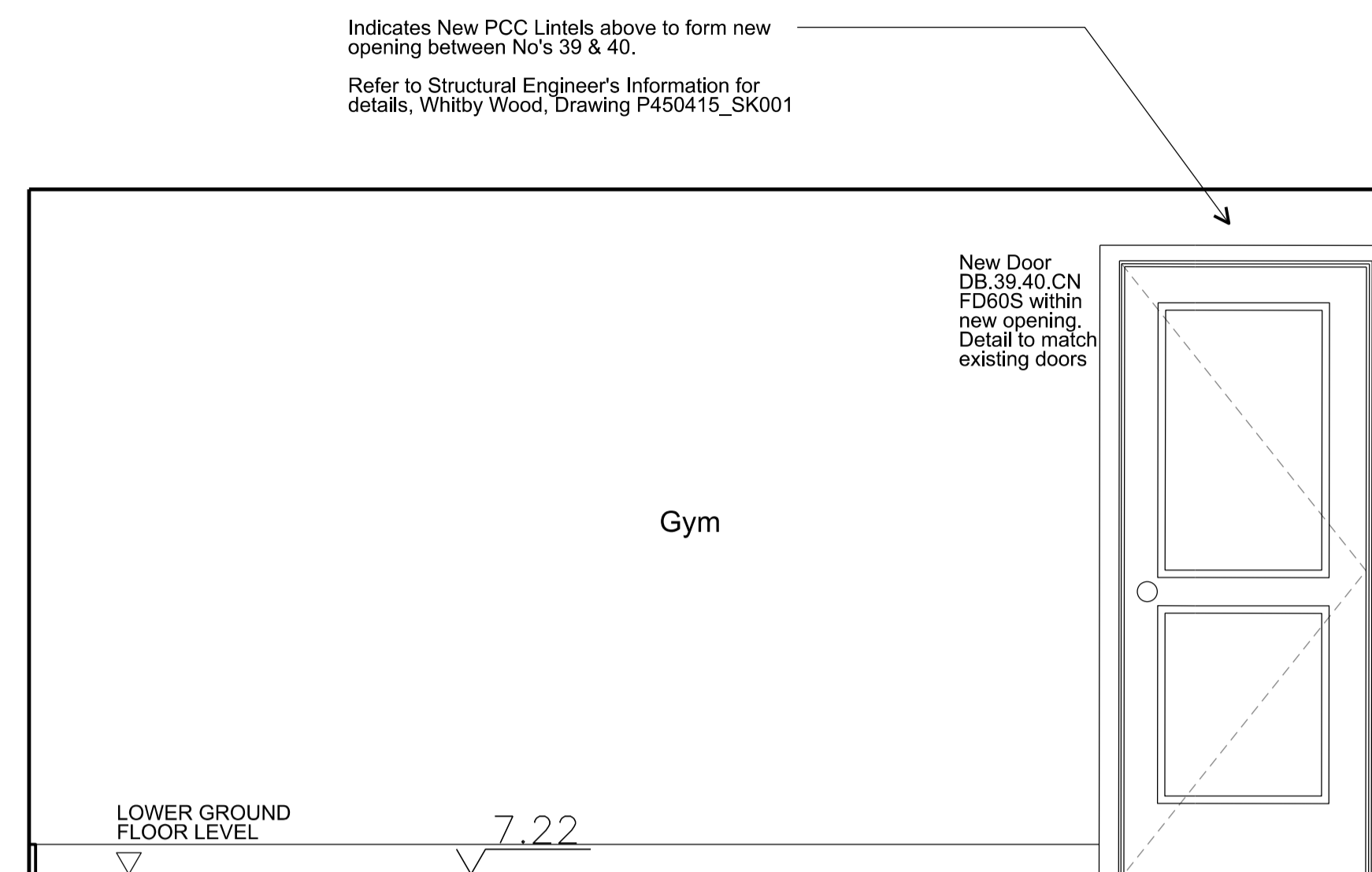
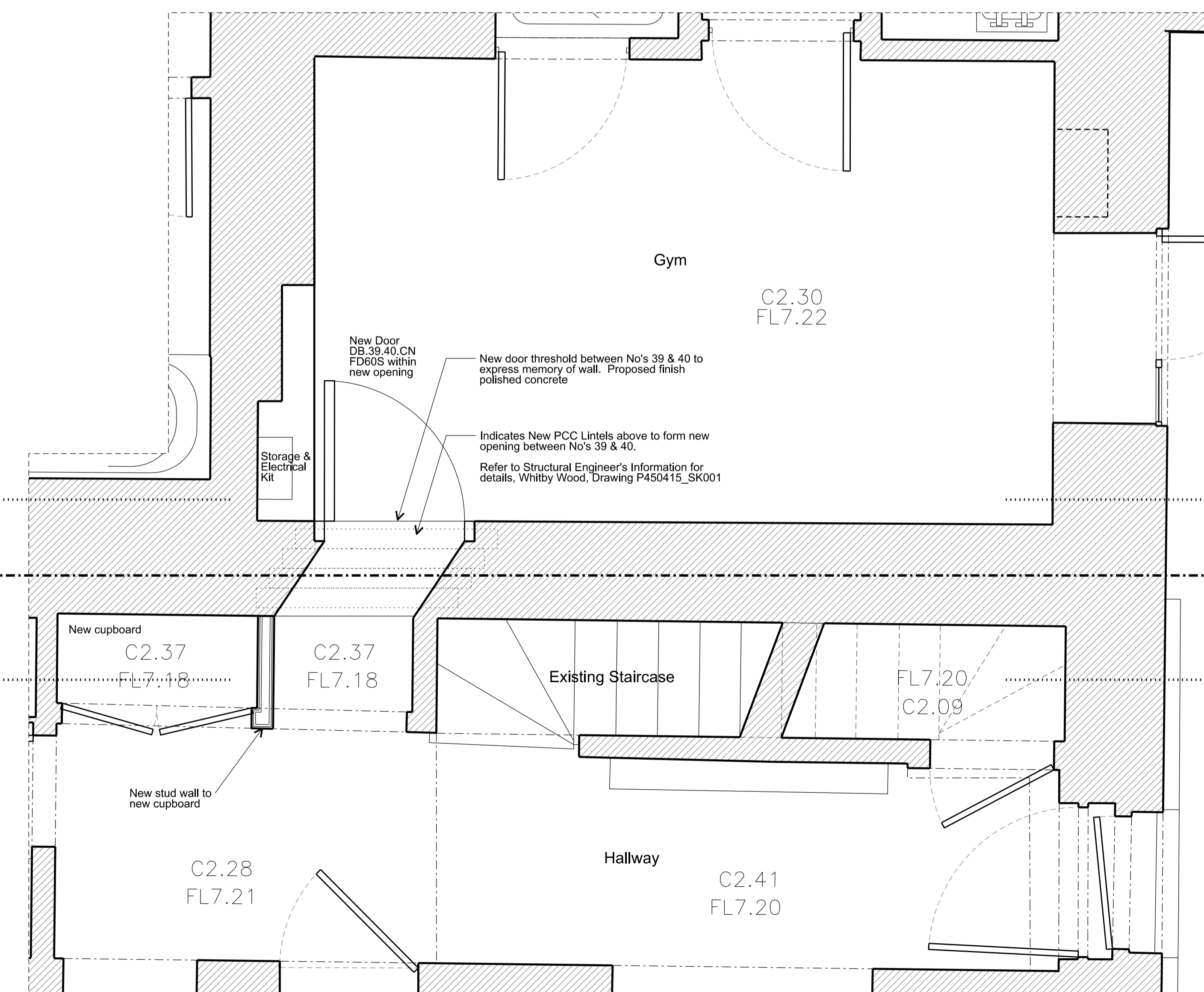

PROPOSED PART PLAN AT LOWER GROUND FLOOR LEVEL TO NO'S 39 & 40

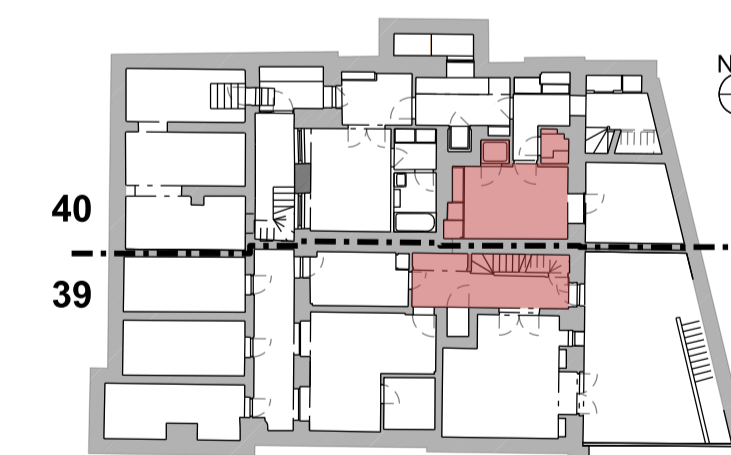

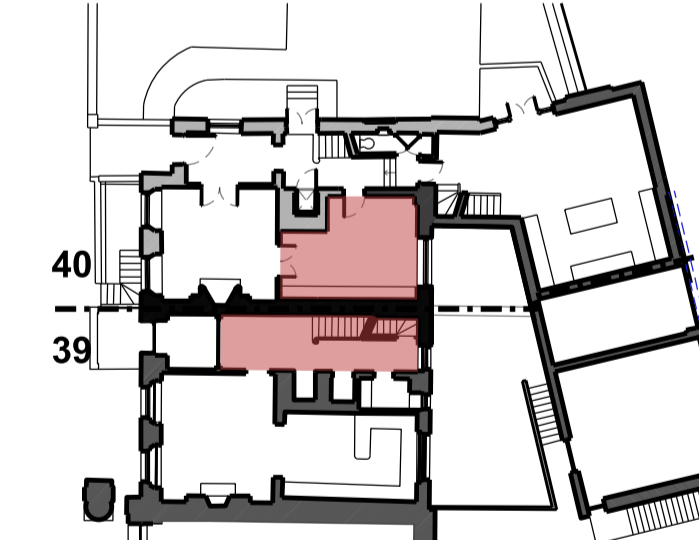


GROUND FLOOR PART PLAN TO NO. 39 & 40

PROPOSED FIRST FLOOR PART PLAN TO NO. 39 & 40

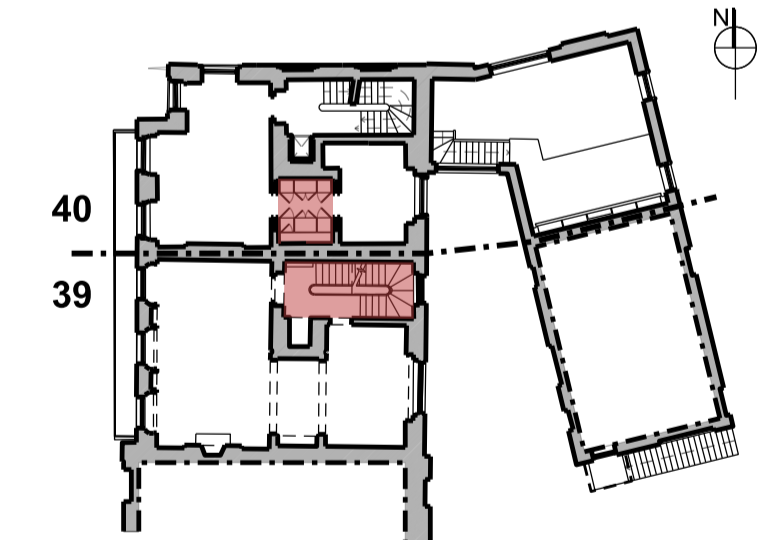
