## TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED) 15 – 17 TAVISTOCK PLACE, LONDON, WC1H 9SH DISCHARGE OF CONDITION 8 PERSUANT TO PLANNING PERMISSION REF: 2017/5914/P (amended application 2015/3406/P)

On behalf of our client, the London School of Hygiene and Tropical Medicine please find enclosed an application for the re-discharge of condition 8 of planning permission 2017/5914/P (amended application 2015/3406/P) dated 27 January 2017.

Condition 8 requires:

"Prior to commencement of development (excluding demolition and site preparation and investigation works), details of a sustainable urban drainage system shall be submitted to and approved in writing by the local planning authority. Such system shall be based on a 1:100 year event with 30% provision for climate change and demonstrating 50% attenuation of all runoff or greenfield levels of runoff. The system shall be implemented as part of the development and thereafter retained and maintained."

Condition 8 was previously discharged on the 18<sup>th</sup> December 2019 however following further detailed design it has become necessary to redischarge this condition.

The supporting document accompanying this application provides details of the revised sustainable urban drainage systems at 15-17 Tavistock Place.
