T3-Viburnum tree- 6M-Reduce crown and overhanging branches by up to 2m.

T4-Ash tree- 20M- Crown reduction of approximately 4 metres on all aspects of tree.

T5-Cypress tree- Reduce by approximately 2.5 metres, remove dead branches.
