Hi Laura

I hope all is well.

The trenches are all complete but not very much was found. We were restricted by placement of trenches given the proximity to buildings and the underground.

The following provides a summary the trenches as received from Chris Clay at Allen Archaeology:

Trenches are numbered from Trench 1 in the far corner of site, to Trench 3 nearest the road.

Trench 1: No significant archaeological deposits or features - a 19th century wall from the known building was recorded

Trench 2: Structural remains from 19th century buildings recorded. Pre-dating this were a large discrete cut feature interpreted as a backlot rubbish pit dating to the 18th century, and a further small, undated pit which was sampled.

Trench 3: Structural remains from 19th century buildings recorded. No archaeologically significant deposits or features.

The client is wanting to proceed with their site works. Is this ok with you?

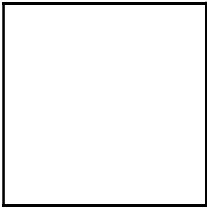

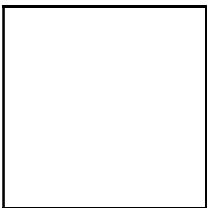
