Many thanks for consulting TfL on the above application. TfL offer the following comments:

The site of the proposed extension is located on the A501 Kings Cross Road, which forms part of the Transport for London Road Network (TLRN). TfL is the highway authority for the TLRN and is therefore concerned with any proposal that may affect the safe movement of pedestrians, cyclists and traffic on the TLRN. However, given its nature and scale **TfL has no objection to the application subject to the following informatives being adhered:**

The footway and carriageway on the A501 Kings Cross Road must not be blocked during any works on the site. Temporary obstructions during the conversion must be kept to a minimum and should not encroach on the clear space needed to provide safe passage for pedestrians or obstruct the flow of traffic on the A501 Kings Cross Road.

All vehicles associated with the works must only park/stop at permitted locations and within the time periods permitted by existing on-street restrictions.

No skips or construction materials shall be kept on the footway or carriageway on the TLRN at any time.
