Rear Garden:

T1: Bay - (closest to the house): Approximately 5.00m. Reduce crown height by approximately 30-40% as is practicable whilst preserving a reasonable amount of crown density. Reduce lateral and sub-lateral branches by approximately 20% whilst maintaining furnishing leaf cover.

T2: Bay: Approximately 9.00m. Reduce crown by 30-40% to include reduction of growth over the neighbouring property.

T3: Mature Oak: Remove major dead wood and several large dead branches which overhang the neighbouring property.

Reason: General maintenance and to control encroachment.
