NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Juniper (T2) - Fell to ground level and grind stump.

1 x Yew (T3) - Reduce crown height and spread by approx. 50%.

1 s Sequoia (T4) - Fell to ground level and grind stump to approximately 300mm below current ground level.

1 x Juniper (T5) - Fell to ground level and grind stump to approximately 300mm below current ground level.

1 x Yew (T6) - Reduce crown by approx. 50%

1 x Macrocarpa (T7) - Remove broken, damaged and hung branches throughout crown.

2 x Yew (T9 & T10) - Reduce height by approx. 1.5m as is practicable. Remove one stem restricting pathway between the trees.

1 x Purple Plum (T11) - Reduce crown by approx. 20% back to previous, most recent reduction points. Thin crown density by 20%. Raise crown by 1m.

3 x Willow (T12, T13 & T14) - Reduce back to previous pollard points.

3 x Irish Yew (T15, T16 & T17) - Reduce crown height and spread by approx. 50%.

FRONT GARDEN: 1 x Hornbeam Hedge - Reduce height to approx. 2.5m.

The Council has considered your notification of intended works to trees dated 13 April 2021 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
