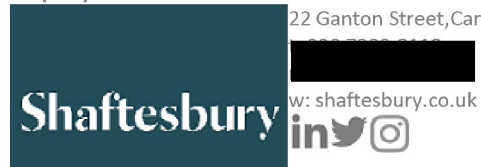
We hope that this application will be approved in order to further support the recovery in Seven Dials and the wider Covent Garden area.
