1 mature Copper Beech at front of property (TPO). This tree has been reduced before. Reduce crown by up to 1.5 metres, cutting to significant growth points to maintain natural flowing canopy outline. This tree is close to retaining wall which is starting to buckle. Maintaining the tree in its current dimensions is essential work to prevent further damage to the wall.

Oak at rear of property: This tree is unbalanced with significant lower, overhanging branches into neighbouring property: Reduce lowest lateral branches by up to 2.5 metres to provide clearance from neighbours patio and garden.
