-Reduce crown height by 3-4meters (regrowth)

-Reduce laterals by 2-3 meters (regrowth) pruning back to leave a bare framework for future management.

T3 - Medium Chestnut

-Remove major deadwood only.

-Carry out an aerial inspection.
