e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We would like to fell the large Rabinia tree as it has become dangerous and too large for its location. There is a strong possibility that the tree will fall as it is growing at about a 35-40 degree angle. There is also decay at the base of the tree making it more prone to falling. The owner and neighbours have enjoyed its interesting shape but due to its weight and condition it has become dangerous and in need of removing as soon as possible. Photos attached.
