				My objections are as follows.	O
				The function room is an important community resource used by local groups for a wide range of activities including art exhibitions, education, campaigning and discussions. To my knowledge, there are no other pubs in the area with a similarly-sized function room providing a relaxed, informal atmosphere for community groups to meet in, both by day and in the evening. Such facilities play a really important role in the well-being of the community.	
				In addition to the value of the function room to the groups that meet there, the function room also contributes indirectly to the local community through its importance in sustaining the character, 'life' and economic viability of the Cock Tavern itself. If the function room is lost, it seems highly likely that the pub itself will go out of business because of the drop in income, and the community would lose a very particular and much-loved meeting place. Pubs are closing at an alarming rate and there is widespread recognition of how detrimental this is to neighbourhoods, both economically and socially.	
				A thriving pub also contributes to the vibrancy of the neighbourhood and this is particularly important in terms of night life: the number and variety of people using the pub and its function room means the streets are that bit safer at night.	
				The National Planning Policy Framework (NPFF, 2019) emphasises the importance of sustainable development i.e. development that meets the needs of the present without compromising those of future generations. Clearly, losing community resources DOES compromise the needs of future generations. Therefore, I consider that this planning application should be rejected.	
				Furthermore, for the reasons described above, I believe that converting the function room to a flat would contravene Paragraph 192 of the NPFF, which states that in determining planning applications, local authorities should take account of the positive contribution that conservation of heritage assets can make to sustainable communities including their economic vitality. As explained above, the heritage asset represented by the Cock Tavern would be seriously damaged if the function room were permanently lost because the local groups meeting there contribute to the 'life' of the community and of the pub itself, not to mention its economic viability. For this reason too, I consider that the planning application should be rejected.	
				There are feasible ways of resolving the issue of the fire escape for the function room; I feel this is being used as an excuse to reap short-term profit from the premises rather than recognizing the heritage value and the importance to the community of the Cook Tayern in its pre-pandemic form, with its function room.
