T1: Pear: Remove Rose & Wisteria from the crown as is practicable without causing bark or structural branch damage. Thin crown density by 20%. Reduce crown by approximately 20% (reducing overlong branches back into main crown structure). Reduce lateral and sub lateral branches overhanging the lawn area by 25%.

Reasons: If not removed the climbing plants will be detrimental to the trees health & to increase light levels to the lawn area.
