e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Purple Plum - (centre lawn): Approximately 8.00m. Reduce crown by approximately 25-30% ensuring a natural crown line is retained. Thin crown density by 20%. Remove dead wood throughout.

T2: Birch - (lefthand side of rear boundary): Approximately 12.00m. Reduce overlong extraneous branches back into main crown structure (not more than 20%). Thin crown density by 15-20%. Remove dead wood throughout.

T3: Birch - (centre of rear boundary): Approximately 10.00m. Reduce extraneous over long branches back into main crown structure (approximately 20%). Thin crown density throughout by 20%. Remove dead wood.

T4: Birch - (righthand side of rear boundary): Approximately 10.00m. Thin crown density by up to 20%. Remove dead wood. Remove climbing plant back to hedge height. Reduce overlong extraneous branches back into main crown structure.

Reasons: General maintenance to increase light levels, reduce hazard potential and help manage the trees at reasonable sizes for their locations.
