e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Snakebark Maple: Approximately 7.00m. Reduce crown by approximately 1.00-1.50m by means of reducing overlong extraneous branches back into the main crown structure. Thin crown density by 20%. Remove Clematis throughout tree.

T2: Holly: Approximately 7.00m. Reduce lateral and sub-lateral growth overhanging planting beds by 20% to help form a more compact hedge line.

T3: Cotoneaster: Approximately 5.00m. Reduce crown by approximately 30% (1.00m). Thin crown density by 20%. Remove dead wood.

T4 & T5: 2 x Limes: Approximately 7.00m. Reduce joint crowns heights by approximately 1.50m. Lightly reduce lateral and sub-lateral growth overhanging beds by up to 1.00m to control encroachment whilst preserving screen and density.

T6: Magnolia Grandiflora: Approximately 6.00m. Tip prune to reduce by approximately 1.00m.

Reason: General maintenance & to control encroachment.
